

## **Terms of use for the Stellplatz Bad Aachen, Branderhofer Weg 11, 52066 Aachen**

These terms of use form an explicit part of the contract between the user of the Stellplatz Bad Aachen (hereinafter referred to as the "Site") and the Kur- und Badegesellschaft mbH Aachen (hereinafter referred to as "KuBa"), which operates the Site.

### **1. Right of owner/occupier of premises to undisturbed possession**

KuBa has the right of the owner/occupier of the Site to the undisturbed possession of it. It may refuse to admit certain persons and/or send persons and vehicles away from the Site where this is in KuBa's interests or in those of other users of the Site.

### **2. Vehicles**

- a) German road traffic regulations apply on the Site. Driving outside the designated routes is prohibited on the Site. Vehicles may only be driven at walking pace. Access to the Site is generally reserved only to the vehicles of the Site's users.
- b) All vehicles, regardless of whether they are campers, caravans or cars, may be parked only in the pitch allocated on the relevant usage agreement.
- c) Vehicles may not be washed, repaired or serviced on the Site.

### **3. Number of users**

The pitch may only be used by the number of persons specified in the usage agreement.

### **4. Tents**

Tents may be erected only in the area designated. Vehicles may not be driven in this area and may not be parked there. They must be parked in the designated parking areas.

### **5. Pets**

- a) Dogs, cats and other pets are allowed on the Site in principle. They must be kept in the vehicles.
- b) When outside the vehicle, all animals must be kept on a leash. The pet owners have a duty to avoid any faecal matter being deposited on the Site and/or must eliminate all such matter immediately and properly.
- c) Care must be taken to ensure that the animals do not cause noise pollution which may affect the stay of other users. Animals are not allowed in the washrooms or utility rooms.

### **6. Cleanliness**

- a) The pitches, all facilities, the supply and disposal stations and the park areas are to be treated with care and kept clean. They must be left clean after use.
- b) Entering the shower cubicles with outdoor shoes is not allowed.
- c) Children under 6 may enter and use the washroom facilities only if accompanied by an adult.
- d) Faecal matter and waste water must be collected in suitable containers and deposited at the disposal point.
- e) Rubbish must be disposed of separately in the designated containers. The disposal of hazardous waste or large amounts of rubbish which is beyond normal household use is prohibited.

- f) Any damage must be reported to KuBa immediately.

### **7. Quiet times in the middle of the day and at night**

On Site, a quiet period is observed from 13:00 to 15:00 and at night from 22:00 to 07:00. During these periods, all noise should be avoided, in particular noise emanating from radios, televisions or other such devices.

### **8. Gas**

If the user has a liquefied gas installation, he/she must carry an official certificate and submit it voluntarily when checking in.

### **9. Barbeques**

- a) Barbecuing on the Site is allowed only if suitable equipment is used. Generally, only electric or gas barbecues may be used.
- b) Insofar as it does not cause a nuisance to other users through odours and smoke, the use of coal barbecues is permitted. Ashes may be disposed of only after they are fully cooled.
- c) Campfire and open fires are prohibited on the Site.
- d) We expressly recommend the use of our "BBQ-corner" (see the signposting on the site). Here guests can also make use of our grill.

### **10. Use**

- a) The course aims to promote individualised tourism for the city of Aachen.
- b) Use for residential purposes is not permitted.
